

VISA UNLIMITED TENNIS CONTRACT



Monthly payments of \$35 + tax for 9 months (September - May) will be billed. Open court time is free in June, July, and August. Billing starts in August for the Month of September.

What is Open Court Time?

Open Court Time is Tennis court time for personal use. Elite Sports Club sponsored tennis programs, lessons, drills, permanent court time, or league play is NOT considered open court time. Anything other than personal tennis use of the court will have additional fees and is not considered part of the Unlimited Open Court Time. Ball machine and ball rental are not included in the unlimited open court time.

The Agreement

- Membership must be in good standing and have a payment method on file.
- This agreement is good for one individual and is valid through May 31st. (All members on an account need to sign their own agreement.)
- Unlimited Open Court Time is **valid only at Elite Sports Club- North Shore** (5750 N. Glen Park Rd. Glendale, WI) **and Elite Sports Club-West Brookfield** (600 N. Barker Rd. Brookfield, WI).
- Agreement to be used only for Open Court Time and cannot be used for Permanent Court time, leagues, tournaments, or socials.
- **NOT VALID** at Elite Sports Club- Mequon, Elite Sports Club- Brookfield, or Elite Sports Club- River Glen.
- There is no pro-rating for this agreement.

The Rules

- Court Fees: Unlimited Court time users are free. Non-unlimited participants are responsible for their share of the court fees.
- Singles & Doubles reservations may be made up to one week in advance.
- Court Reservations can be made up to 90 minutes in length.
- Allowed to make one court reservation (90 min max) per day in advance. If multiple courts are available at the end of your "one per day" reservation, you may extend your reservation with front desk approval.
- Available during all hours of Tennis Court operation.
- List other players on the reserved court. If you play with a person who is not on unlimited play, their portion of the court time must be paid by them.
- Cancellations must be made at least 24 hours in advance of play to avoid cancellation charges.
- No shows will be charged \$25 per reservation missed. All parties on the reservation will split the cost regardless of the agreement.
- Any abuse of reservations will result in a \$25 penalty charge. Multiple abuses may result in revocation of this contract.

The total price of the unlimited tennis contract is \$315 + tax.

UNLIMITED TENNIS OPEN COURT TIME FREQUENTLY ASKED QUESTIONS

Is this agreement available to everybody on my Elite Sports Club membership?

This agreement is for one individual only. If multiple members on the same membership want to use the Unlimited Open Tennis, each member must purchase their own Unlimited Open Tennis.

What type of membership do I need to be eligible to purchase the Unlimited Open Tennis?

- All Junior Tennis memberships can purchase the Unlimited Open Tennis. Junior Tennis members are allowed to use this at both Elite Sports Club- North Shore and Elite Sports Club- West Brookfield.
- Elite Sports Club Individual, Couple, or Family tennis members can purchase this Agreement. Agreement is on a per person basis. Unlimited Open Tennis is available at Elite Sports Clubs- North Shore or West Brookfield locations.

What is considered a “Court Reservation”?

You are allowed to make one court reservation in advance per day. If you are playing with another unlimited open tennis player, your court reservation with that person is considered one reservation. Therefore, you cannot make another court reservation under the other person’s name without violating this rule.

My club has no open courts. Can I use my Unlimited Open Tennis at another club?

There are no exceptions to play at a club that is not part of this agreement. We do have many lessons, social events, and tournaments that may make the tennis courts unavailable. Please be aware that in the case of a conflict you will be unable to use your Unlimited Open Tennis.

Elite “open” court time is scheduled around lessons, leagues, permanent court time, and events. Elite has limited open court time Monday - Thursday, 4:00 pm to 8:00 pm and Saturday 9:00 am - 12:00 pm. Elite also hosts many large tournaments from time to time, limiting certain weekend court availability. Elite Sports Clubs- North Shore hosts a significant amount of weekend tournaments.

Can I get a pro-rated Agreement?

Current members **CANNOT** get a pro-rated agreement. New members must purchase within first month of membership and continue to May 31st.

What happens if I bring a guest?

If you bring a guest to participate on the court during your open tennis time, your guest must pay a guest fee as well as their portion of the court fees.

Can I play more than 90 minutes in a row?

FREQUENTLY ASKED QUESTIONS

Is this agreement available to everybody on my Elite Sports Club membership?

This agreement is for one individual only. If multiple members on the same membership want to use the Unlimited Open Tennis, each member must purchase their own Unlimited Open Tennis.

What type of membership do I need to be eligible to purchase the Unlimited Open Tennis?

- All Junior Tennis memberships can purchase the Unlimited Open Tennis. Junior Tennis members are allowed to use this at any of the Elite Sports Club locations.
- Elite Sports Club Individual, Couple, or Family tennis members can purchase this Agreement. Agreement is on a per person basis. Unlimited Open Tennis is available at any of the Elite Sports Club locations.

What is considered a “Court Reservation”?
